FEATURED TALK PRESENTER BIOGRAPHIES

Alisha Griffin is the Director of the California Department of Child Support Services. She has been with the child support program for more than 17 years and came to child support with many years in public and private family services, including child welfare, child protection, rehabilitation and therapeutic service systems. She most recently assumed leadership of the California Child Support program after leading New Jersey, since the implementation of PRWORA. While in New Jersey, she successfully led the design, procurement, implementation and management of the first second-generation national model child support automated system, including substantial pre-and post-change management strategies. Additional focus on practice improvements and ensuring efficient and effective service delivery resulted in a comprehensive streamlining of all collections and disbursement systems and overarching fiscal management coordinated with revamping customer service through creating a centralized comprehensive, one-stop, quality driven service model, with comprehensive performance metrics. She also has a strong portfolio of experience in direct service programming, policy analysis and development and advocacy focused on quality service delivery to children and families.

Ms. Griffin has chaired, participated and worked on many national workgroups and designed several model programs, both in the child support and child welfare arenas. She has served as past President of the National Child Support Enforcement Association (NCSEA) and the National Council of Child Support Directors (NCCSD). She currently serves on NCSEA's International and Policy and Government Relations committees. She serves on the Executive Council of NCCSD and the chair of the subcommittee on Medical Support, which

addresses issues related to child support and the impact of implementation of the Affordable Care Act. She represented NCSEA for all five years as a member of the delegation to The Hague Private Law Convention on Child Maintenance and Family Support and served as an observer/program advisor to NCCSUL on the revisions to UIFSA to incorporate the new convention into US laws. Because of her expertise, she was invited to testify to the Senate Foreign Relations Committee on The Hague Convention and its benefits to the US children and families.

Ms. Griffin continues her dedication to families and community on several other levels. She has also served as President and Senior Advisor for the National Family Preservation Network (NFPN), providing leadership on grant acquisition, media relations and fatherhood services and helped NFPN acquire numerous grants to further the work of preserving and strengthening families. Ms. Griffin has a Masters in both Clinical and Community Psychology.

Camille Maben, Executive Director of First 5 California. In that role, she is responsible for staffing the California Children and Families Commission, in addition to directing the work of the agency and its staff. Through her leadership, first 5 California is implementing several evidence-based and results-driven Signature Programs targeted to children, parents and teachers that focus on quality. Prior to her appointment at First 5 California, Ms. Maben served as the Division Director of the Child Development Division at the California Department of Education (CDE). Responsibilities in that role included providing leadership and oversight to over 700 early care and education contractors with a 1.7 billion-dollar budget. She most recently served as Co-Chair of the State Advisory Council on Early Learning and Care, and

helped win and implement the \$52.6 million federal Race to the Top - Early Learning Challenge Grant.

In earlier work at CDE, Ms. Maben served as Division Director of the School and District Accountability Division. Her division included the No Child Left Behind Office, oversight of the Categorical Program Monitoring process, the Title I Policy and Partnerships Unit, and the English Learner Accountability Unit. She served as the Superintendent's representative to the California Interscholastic Federation. Ms. Maben also served as Senior Advisor to former State Superintendent Delaine Eastin and has worked as a consultant to the Assembly Education Committee. She currently serves as a school board member for the Rocklin Unified School District. She has served on the Rocklin Board for over 20 years.

Rick Miller is the founder and CEO of Kids at Hope, an international child and youth development organization that studies family, school and community cultures to better understand the dynamics of success and failure. Mr. Miller has spent 48 years in the field of child and youth development as a practitioner, researcher, teacher, public policy expert and author. His research is revolutionizing the understanding of child and youth development and cultures.

Mr. Miller's work is modeled in 21 states and Canada, cited by the American Academy of Pediatrics and adopted by the Arizona Supreme Court to help redefine the juvenile justice system from risk to hope. He is the author of three books and two comic books. He has

received Arizona State University's Visionary Award; the City of Phoenix, Martin Luther King, Jr. Living the Dream Award; and the Freedom Foundation at Valley Forge George Washington Medal. Included in his many keynotes, workshops, seminars and symposiums is a TED Talk. In addition to his work with Kids at Hope, Mr. Miller is a Professor of Practice at Arizona State University's Sanford School of Social and Family Dynamics. He lives in Phoenix with his wife, Esther. They have two children and four grandchildren.

Dr. Jacqueline Del Rosario has developed proven tools to help couples delve through their quarrels and discover healthy approaches to marital circumstances across all boarders. As a marriage coach and wife for over 20 years. Dr. Del Rosario continues to travel coast to coast speaking on and discussing the plights attached to the institution of marriage and under privileged families. Dr. Del Rosario's mantra derives from the idea that the foundation of any society starts in the individual homes of people. In her mission to improve individuals' likelihood for marital success, she also founded ReCapturing the Vision (RTV), a globally recognized nonprofit dedicated to helping the youth and their families overcome negative trends that lead to generational cycles of failure and dependency, a veracity far too common within inner-city neighborhoods of America. ReCapturing the Vision's programs have received over \$20 million in federal, state and local funding. The organization has, to date, steadily propelled empowerment into the lives of the adolescents, their families in school, at home and within their respective communities.

As a marriage coach and certified stateapproved premarital course provider, Dr. Del Rosario has developed proven tools to help couples talk through their problems and find healthy solutions in support of her vision to

break generational cycles of hardship that have crippled so many families.

Her newest tool, BestMarriageKeys.com, is a top website for interactive marriage preparation and training. On BestMarriageKeys.com, Dr. Del Rosario shares her experience of over 15 years as a marital counselor and 20 years in a happy marriage to help individuals improve their likelihood for marital success. She continues to work tirelessly to pave the way for social reform, a new mindset and, most importantly, lighting the path towards an enriched life.

As a recognized public speaker, Dr. Del Rosario has dynamic topics for singles, married couples, professional associations, universities and churches. One of her most popular topics Dating Rules with Dr. D, provides laughter, healing and training to help singles work on themselves and understand the keys to building long lasting and healthy relationships. As an educator, author, advocate, counselor and visionary, Dr. Del Rosario holds a Bachelor of Science in Psychology, a Master's in Education, and a Doctorate of Education in Organizational Leadership. She resides in Miami, FL with her husband of over 20 years and two sons.

Dr. Ronald B. Mincy, Sr. is the Maurice V. Russell Professor of Social Policy and Social Work Practice and Director, Center for Research on Fathers, Children, and Family Well-Being at Columbia University. Professor Mincy's past research has focused on the effects of policies and programs on the roles that young, disadvantaged (especially Black) men play as fathers and workers. Two recently published studies, supported by the Ford Foundation (with Dupree, and with Carlson, Garfinkel, McLanahan, and Wendell Primus), counter the conventional wisdom by showing that higher welfare benefits are associated with more-not less-involvement of unmarried fathers in the lives of their

children and partners, if one broadens the definition of families to include unmarried parents not living in co-residential unions. Income pooling by these fragile families can result in increased visiting by non-resident fathers. However, higher welfare benefits do not encourage cohabiting fathers to marry the mothers of their children, because it is more difficult for married couples to conceal incomepooling. Two other recent papers examine the effects of child support enforcement policies on paternity establishment, child support compliance and father involvement. One paper (with Nepomnyaschy and Garfinkel) uses citylevel data to show that unwed fathers are more likely to establish paternity for their children if they live in jurisdictions with more aggressive inhospital paternity establishment programs and that establishing paternity in the hospital increases visitation. Another paper (with Huang and Garfinkel) shows that the child support obligations faced by low-income fathers are so high that they, in fact, reduce compliance.

Dr. Mincy is a co-principal investigator (with Garfinkel, McLanahan, and Brooks-Gunn) on the recently-awarded grant form NICHD that is supporting collection of the 6th wave of data for the Fragile Families and Child Well-being Study, when the focal children become pre-adolescents (around age 9). He plans to use these data for follow-up studies of the earnings trajectories of unmarried fathers and the effects of union transitions (especially marriage) on earnings trajectories. He also plans to seek support from the Administration for Children and Families to study child support, visitation and health trajectories of unmarried fathers, and the effects of re-partnering by mothers or fathers on these trajectories. Dr. Mincy also plans to study the effects of visitation and child support payments by fathers on mothers re-partnering and on fathers' subsequent fertility. Finally, he plans to evaluate a program that equips non-

resident fathers to reduce violence, substance abuse and early sexual debut among their early adolescent sons (ages 8-12).

Lisa M. Najavits, PhD is Professor of Psychiatry, Boston University School of Medicine; and adjunct professor, University of Massachusetts Medical School. She is a research psychologist at Veterans Affairs (VA) Boston Healthcare System and the Bedford VA; and Director of Treatment Innovations. She was on the faculty of Harvard Medical School for 25 years. Her major clinical and research interests are substance abuse, trauma, co-morbidity, behavioral addictions, veterans' mental health, community-based care, development of new psychotherapies and outcome research. Dr. Najavits is author of over 190 professional publications, as well as the books Seeking Safety: A Treatment Manual for PTSD and Substance Abuse; A Woman's Addiction Workbook; and the upcoming self-help book, Recovery from Trauma, Addiction or Both: Finding Your Best Self, as well as the new treatment manual, Creating Change: A Past-Focused Treatment Manual for Trauma and Addiction. She has served as President of the Society of Addiction Psychology of the American Psychological Association and is on various advisory boards including the Journal of Traumatic Stress; the Journal of Gambling Studies; the Journal of Dual Diagnosis, and Psychological Trauma: Theory, Research, Practice, and Policy. She has received various awards, including the 1997 Young Professional Award of the International Society for Traumatic Stress Studies, the 1998 Early Career Contribution Award of the Society for Psychotherapy Research, the 2004 Emerging Leadership Award of the American Psychological Association Committee on Women and the 2009 Betty Ford Award of the Addiction Medical Education and Research Association. Dr. Najavits is a licensed Psychologist in Massachusetts and conducts a psychotherapy practice. She received her PhD in Clinical Psychology from Vanderbilt University and her Bachelor's with Honors from Barnard College of Columbia University.

Dr. Obie Clayton, Jr., is the Edmund Asa Ware Distinguished Professor and Chair of Sociology and Criminal Justice at Clark Atlanta University. Since 2011, he has been serving as the Donald L. Hollowell Distinguished Professor of Social Justice and Civil Rights Studies at the University of Georgia's School of Social Work, Previously, he was director of the Morehouse Research Institute and served on the faculty at the University of Nebraska at Omaha and the University of Massachusetts at Boston. He is the editor of An American Dilemma Revisited: Race Relations in a Changing World (Russell Sage Foundation, 1996) and co-editor of Black Fathers in Contemporary American Society: Strengths, Weaknesses and Strategies for Change (Russell Sage Foundation, 2003). Professor Clayton holds a Master's and a Ph.D. in Sociology from Emory University in Atlanta. Dr. Clayton received his undergraduate degrees in Religion and Sociology from Millsaps College in Jackson, Mississippi and the Master's and Doctoral degrees from Emory University. Dr. Clayton has held teaching positions at the following institutions: Millsaps College, Atlanta University, the University of Massachusetts at Boston and the University of Nebraska at Omaha. His research and teaching interests are primarily in the areas of family studies, stratification and crime and delinquency. Dr. Clayton's current funded research is in health disparities and teenage sexuality. He has received funding in the past from the Office of Population Affairs/DHHS to train young men in safe sex behavior and responsible health practices. Dr. Clayton is also the Principal Investigator for the National Minority Male Health Project funded by the Office of Minority Health/DHHS. Other research activities include studies of urban inequality and he was part of a research team that studied this

problem in four American cities: Atlanta, Boston, Detroit and Los Angeles. This study was funded by the Ford and Russell Sage Foundations. Other research projects which Dr. Clayton is involved include: (1) A study of the impact of immigration on the Atlanta workforce (funded by the Bureau of the Census) (2) Jobs and Job Training for African Americans (funded by the Department of Labor) and (3) The impact of Mass Transit in Atlanta (funded by the Department of Transportation). Dr. Clayton also received a grant from the National Science Foundation to expand the infrastructure of Morehouse College to conduct basic and exploratory research on the etiology of violence and asocial behavior.

Dr. Delia Robinson Richards' Bachelor's. Master's and Doctoral degrees are in early childhood education. She has presented at many education conferences in the United States, the Caribbean and Central America. She is a Fulbright Scholar who developed and implemented an early childhood program at the University of the West Indies in St. Augustine, Trinidad. Her research is on multiple intelligences in the early childhood curriculum, identifying the perceptions of Black fathers about the responsibility for their children's education, urban education - a perspective from University students, and children's first experiences in school. Dr. Richards is an Assoc. Professor in Early Childhood Education and CEO of BEEK3 (Beyond Expectations in Education) an educational consulting company that provides services to educators, families and caregivers of children between the ages of 3 to 8 years or from Prekindergarten to Third Grade.

Debra Samples is the Regional Program Manager for Children's Bureau Region 9 in San Francisco, CA. She and her team provide oversight to States and Tribal federal Child Welfare Programs in Arizona, California, Hawaii, Nevada and the

outer pacific territories of American Samoa, Guam and Commonwealth Northern Marinara Islands. Ms. Samples has more than 30 years of child welfare experience, including state and county-level work across two states—Georgia and California. She has spent the last 15 years with the Children's Bureau Region 9 office and brings a wealth of knowledge about the policies and requirements needed for grantees to operate the federal child welfare programs.

She has devoted her career to ensuring good outcomes in the areas of safety, permanency and wellbeing of children and families touched by the child welfare system. Ms. Samples worked for many years providing direct work with children and families and as an adoption worker and managing a foster adoptive parent recruitment project. Services Program Administrator 3 in the Office of Child Support for many years.

Director Dent does extensive community outreach and public speaking about the message that promoting responsible fatherhood is much less costly than paying for the consequences of father absence. When fathers acquire the skills, they need to be responsible fathers, children are better off and better positioned to build their own strong families; families are better off because of fathers' love, care and emotional and financial support; and taxpayer dollars are saved as families are more likely to be well-functioning and self-sufficient.

Ms. Dent serves as Co-Chair of the Ohio Collaborative to Prevent Infant Mortality Fatherhood Involvement Workgroup, a member of Ohio's Child Support Strategic Workgroup and a member of Ohio's Ex-Offender Re-Entry Coalition. She holds a Bachelor's in Political Science from the University of Pittsburgh, a Master's in Public Policy and Admin from Ohio University and is a candidate for her Doctorate in Law and Public Policy at Walden University.

Professor Thalia González teaches and writes in the fields of restorative justice, juvenile justice, education, civil rights, domestic human rights, law and society and public interest practice. She is an expert in the field of restorative justice and conflict transformation and her work on restorative practices, race and inequality, the school-to-prison pipeline and public policy has been utilized by educators, policymakers, county safety councils, think tanks and bar associations. Her recent publication, Restorative Justice from the Margins to the Center (2017), is the first article to trace the emergence of school-based restorative justice in the United States and its subsequent cascade and institutionalization as a new school discipline norm.

Professor González seeks to engage contemporary questions at the intersection of law, society, inequality and systemic reform. She has published articles, book chapters, policy reports and issue briefs in a variety of publications including New York University Review of Law and Social Change, Howard Law Journal, Cardozo Journal of Conflict Resolution, Fordham Urban Law Journal, Ecology Law Quarterly and the Journal of Law and Education. She is a frequent expert speaker at conferences and a commentator on legal issues and educational and juvenile justice policy. Professor González is co-author of Girlhood Interrupted: The Erasure of Black Girls' Childhood (with Rebecca Epstein and Jamilia Blake), the groundbreaking study examining the adultification of Black girls, finding that adults perceive Black girls as less innocent and more adult-like than their white peers.

Professor González has been recognized for her excellence in teaching, including being awarded the Linda and Todd White Teaching Prize, the Loftgordon Teaching Award and selected as a Mortar Board Last Lecture speaker. She was a member of the Research to Practice Collaborative of the Civil Rights Project at UCLA and has worked as a consultant for the National Institute of Justice. She has been a Visiting Scholar at Berkeley Law, UCLA School of Law, and Georgetown University Law Center. Prior to joining the faculty at Occidental College, she was a practicing attorney and held appointments at the University of Denver Sturm College of Law and Arizona State University. She has chaired and been a board member of numerous organizations and is currently Board Chair of CADRE and serves on the national leadership team of the Yoga and Body Image Coalition.

organization that was legally incorporated in 2009. It is a grassroots support and empowerment group for men who are committed to strengthening their role as fathers. From what began as a once per week support group has evolved into a full-service father's program. Mr. Simpkins holds a BA Degree from the City College of New York. His credentials also include a Master's from the State University at Albany. He was awarded the Commission of Human Rights Individual Achievement Award and the New York State Citation for Community Contributions.

Anthony Mossburg, a musician with four original albums in four years left the stability of a fulltime job to chase after the only thing that made him feel alive - music. What followed over the next four years was a series of accolades, achievements, risks, near misses and setbacks that indefinitely shaped him as an artist and a person. Dr. Fermin's focus is on the issues that immigrants and the children of immigrants' face concerning persistence and completion of education.

Jeffery M. Leving, LTD, The Law Offices of Jeffery M. Leving, Chicago, Illinois, is a Chicago divorce attorney and author who specializes in matrimonial and family law. He is known primarily for his vocal advocacy of fathers' rights and hosts two radio shows. His television and radio commercials are well known in the Chicago area. More than 30 years ago, Mr. Leving helped pioneer the Fathers' Rights Movement when he discovered a gap in the judicial system. It was at that point that he started seeking equality and due process for fathers everywhere. Mr. Leving's accomplishments include the co-authorship of the Illinois Joint Custody Law, Illinois Virtual Visitation, Right to DNA Testing Notice, and Unlawful Visitation or Parenting Time Interference Laws. He also delivered testimony before both branches of the Illinois Legislature on Joint Custody, Grandparent's Visitation and Child Support Accountability bills.

Criminal Division lawyer. After a two-year break in the United States Army on active duty, he returned to the U.S. Department of Justice where he served as a Special Assistant to Attorney General Robert F. Kennedy on major criminal cases and as a monitor of the Civil Rights Movement. In April 1965, he became a Senior Assistant United States Attorney in the District of Columbia where he served for almost four years before becoming the Legal Advisor (now called General Counsel) for the Metropolitan Police Department following the aftermath in the District of Columbia resulting from the assassination of Martin Luther King, Jr. In the interval between serving as U.S. Magistrate Judge (1969-1975) and (1980-1987), he served as the Chief Legal Advisor for the Civil Service System and Legislative Counsel to President Jimmy Carter on all civilian personnel and government reorganization matters. In 1987, he was appointed to the Superior Court of the District of Columbia by President Ronald Reagan and served as a full-time active Judge until October 1998, at which time he took Senior Judge status, but continued to sit full-time and serve in a volunteer capacity as Judge-in-Residence to the Children's Defense Fund. In April 2004, he was one of the Principal Founders of the National African American Drug Policy Coalition, Inc. under the leadership of Clyde E. Bailey, Jr., then President of the National Bar Association.

In March 2017, he was selected by the International Association of Top Professionals as Top Judge for 2017 from over 50 judges considered from all over the world. In April 2017, he was chosen by Who's Who in America for the Albert Nelson Marquis Lifetime Achievement Award, named after the founder of Who's Who, the highest recognition given by that organization. Finally, in June 2017, coauthored the book Pieces Never Missing Required in a Child's Life, dealing with the idea

of what fathers' engagement should be in their children's moral values development and education in America for the future of this Nation.
